Salt Lake City, Utah.

Gentlemen:

In behalf of a large number of the Greek population of the State of Utah, I hereby request your Honorable body in the interest of justice and law enforcement, that you deny the application of Gust Zaharopoulos for the termination of his sentence imposed by the District Court of Carbon County at Price, Utah. He is under sentence the second time for crimes of which he has been adjudged guilty.

During the administration of Governor Bamberger, this same Gust Zaharopoulos had been convicted of killing his wife and obtained a commutation of sentence from life imprisonment to five years, a part of which only he was required to serve. Since his release, he has been a generally bad man and has brought much reproach upon the law abiding element of the Greek community who feel to request that the Honorable Board of Pardons refuse to extend any further leniency and that the said Gust Zaharopoulos be required to pay the full penalty for the crimes of which he was convicted in the District Court of Carbon County, at Price, Utah.
